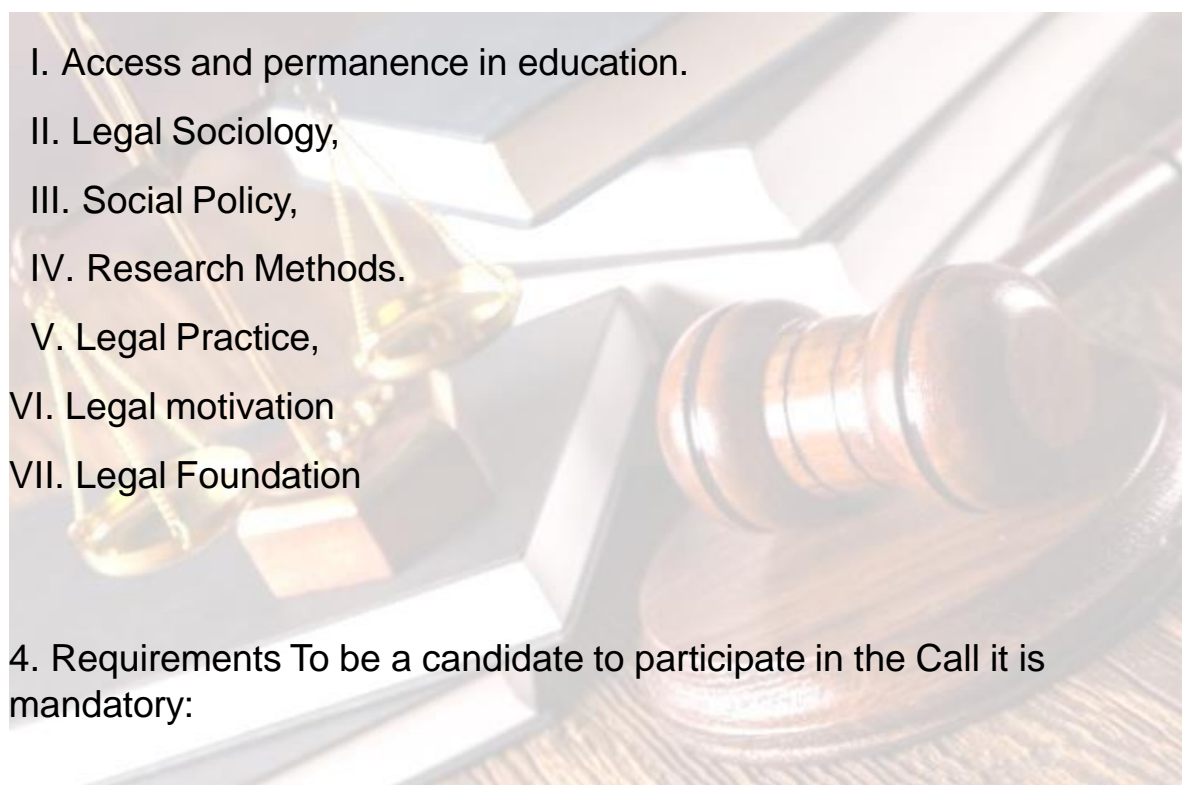

5. Submit a bill for reform, addition or initiative of law (hereafter referred to as the "Project") that has a direct impact or benefit for the society of the various nations considering that law students participate in this project

The Project must meet the following requirements as a minimum:

C. Title of the draft reform, addition or initiative of law.

d. Introduction or presentation.

and. Content development (it is suggested to answer the following questions; What law and / or article is created, amended, added and / or repealed? What is the purpose of the proposal? Why is it considered that said law and / or article must be created, reformed, added or repealed? What specific population is it aimed at? What quantitative and qualitative impact would it have for the benefit of society? Support through research and verifiable data).

Draft Decree (this section establishes in a timely manner only the changes or additions suggested in the corresponding law)

The Project must be submitted with writing on one side of the sheet, double spaced, with Arial type font, size 12 points

and established margins of 2.5 cm on each side, with a minimum of 5 pages and a maximum of 10.

It is suggested not to include images in the Project.

All Projects must be original.

Adaptations of other works or authors will not be accepted.

Total or partial plagiarism is strictly prohibited, the participant who incurs in this offense will be automatically disqualified.

Projects should not include messages that attack any natural or legal person, public or private, or that incite gender or religious discrimination.

Each participant can do it in a single theme.

#### 6. Project Delivery and documentation / Registration

1) All Projects must comply with the requirements specified in these rules, otherwise they will be grounds for automatic disqualification.

to. When sending the email will include:

1.- The Project of the participant in PDF format indicating in the first sheet (cover) the title of the material, as well as the category and theme in which it participates. No worksheet, or the cover, should include the name of the participant, or any data that leads to their identification, as this will be grounds for disqualification.

The above with the purpose of avoiding all kinds of benefits in the evaluation of the Projects by the jury.

An additional sheet will include the contact details of the participant: Name of the participant, full address where the participant's email address can be found, and two telephone numbers where he can be reached.

The Projects will be received during the term of this call from Monday to Friday at a free time 24 hours a day and clarifications or doubts during an office hours from 10:00 a.m. to 4:00 p.m.

The reception of Projects will be from the publication of this Call and until October 31, 2021.

The work sent by email will be taken into account the date the email was sent.

The works that are received outside the mentioned terms, will not be considered in the Call.

## 7. Evaluation Criteria

The jury will evaluate the projects of the participants taking into consideration the following criteria:

- a) Knowledge on the topic of participation.
- b) Analysis.
- c) Synthesis.

- d) Writing.
- e) Use of reliable sources.
- f) Viability of the proposal.

## 8. First Stage Mechanics:

1) Once the Call is closed, the documents received that have met all the requirements of these Terms and Conditions will be evaluated by the Qualifying Jury, who will give a maximum of three finalists for each category.

\*The competition will have to have a minimum of 150 participants without exception to access the first place award of the call, otherwise only the medal corresponding to the first place will be awarded, recognition signed by international judges

For each subject there will be a Jury composed of three members, of the international committee of EACH THEME (RIGHT)

1)The Organizing Committee will integrate a register of people from the private, academic and social sectors, with prestige in the respective topics, from which the members of each Jury will be selected.

2)No person who has submitted Project in this Call may be part of the Jury.

3)Once the Projects have been received, the INTERNATIONAL Committee will verify that they meet the requirements established in this Call and if so, it will take the documentation to the respective Jury for evaluation.

4)The Juries will make their decisions by majority vote and their resolutions will be final.

5)Cases not provided for in this call will be finally resolved by the INTERNATIONAL Committee

6)The final works that have initiatives of law will be delivered to the legislators of the different commissions of the congress of the Union for their analysis and possible presentation to the plenary for approval.



## **RULES OF THE GUERRERO JAGUAR INTERNATIONAL PRIZE.**

**1.- This is an anonymous competition and the Unique Registration Number is the only means of identification.**

**2.- The official language of the prize is English.**

**5.- It is forbidden to contact the jury.**


**INSTITUTIONS:** This option is open to institutions interested in sponsoring their students to participate in the Jaguar Guerrero International Prize.
